

**West Ohio Annual Conference  
Local Church Insurance Recommendations**

The 2012 Book of Discipline, Par. 2533.2 requires local church trustees to annually review and report on the adequacy of local church property and liability insurance coverage *"to ensure that the church, its properties, and its personnel are properly protected against risks."* In an effort to provide further local church guidance, the General Counsel on Finance and Administration (GCFA) developed and recommends the coverage levels below for a *typical* United Methodist Church. The West Ohio Conference Board of Trustees affirms this guidance from GCFA and encourages West Ohio local churches to strongly consider these recommended coverage levels.

When choosing a church insurer, please follow these guidelines:

- Choose an insurance company that has a specialization in covering churches and religious organizations
- Choose an insurance agent who has experience with providing insurance to churches
- Assess what is unique to your church that leads to the need for higher coverage levels (e.g., operating a day school or a historically significant stained glass window or other artifact) or lower coverage levels (small membership churches without weekday programming)
