Becky Schofield Motter will share how *Scripture and United Methodist Tradition* have led her to provide housing and Sanctuary to asylum-seekers in partnership with Clifton UMC and a network of other congregations. Finally, we will invite you to participate in a *Reasoned* communal response, in partnership with the [Task Force on United Methodist Immigration Ministries of Ohio](#). Participants will have the opportunity to write a letter to a detained asylum-seeker and/or send postcards to our policymakers to share what The United Methodist Church believes about migrant justice.

- **What's Your Number? The UMFOW Stewardship Standards – session 3**
