Driver License Status

- **VALID** the driver has a valid Ohio driver license.
- **NOT VALID** the driver does not currently have an Ohio driver license but is eligible to obtain one.
- **EXPIRED** driver license is expired, but person is eligible to obtain a license.
- **SUSPENDED** driving privileges are currently under a hard suspension.
- **SUSPENDED/PRIVILEGES** driving privileges are currently under a hard suspension. A court has granted limited driving privileges and/or authorized a payment plan for reinstatement fees. Driver must carry a document from the courts detailing when and where they are allowed to operate a vehicle.
- **FAILURE TO REINSTATE** the hard suspension has expired. Driver must comply with remaining reinstatement requirements.
- **FAILURE TO REINSTATE/PRIVILEGES** the hard suspension has expired. Driver has satisfied all reinstatement requirements with the exception of paying the reinstatement fees and court has authorized a payment plan.

CDL Disqualification (DL)

A driver's privilege to operate a commercial motor vehicle is disqualified when he or she is convicted of certain violations in a private passenger vehicle or commercial motor vehicle.

- No CDL driving privileges are permitted during the disqualification.
- Disqualification may last from 60 days to a lifetime

Reinstatement Requirements:

- Serve disqualification period
- Pay \$40 reinstatement fee

License Forfeiture (LF)

Imposed by the court when an individual fails to appear in court

- Not eligible for driving privileges
- Individual must satisfy court requirements.

Reinstatement requirements:

- Official court release
- Pay \$25 reinstatement fee

Warrant Block (WB)

A Municipal or County Court may send the Ohio Bureau of Motor Vehicles (BMV) a report for any person for whom there is an outstanding court issue.

- Any driver license or vehicle registration transaction will be denied.
- Not eligible for driving privileges

- Official court release
- Pay \$15 reinstatement fee

Violator Compact Suspension (VC)

An out-of-state court informs the Ohio BMV an Ohio licensed driver failed to appear for a traffic ticket.

Not eligible for driving privileges

Reinstatement Requirements:

- Official Court receipt showing paid in full
- Pay \$30 reinstatement fee

Non-Compliance Suspension (NC)

Failure to show proof of insurance at time of citation or accident.

Reinstatement requirements:

<u>If insured:</u> The suspension can be removed if driver provides valid proof of insurance that covers the date of the traffic stop or accident to the BMV.

If uninsured: Pay the reinstatement fee, serve the suspension time, and maintain SR-22

- 1st offense Pay \$40 fee, Indefinite Suspension*, 1 Year SR-22 *until requirements satisfied
- 2nd offense Pay \$300 fee, 1 Year Suspension, 1 Year SR-22
- 3rd + offense Pay \$600 fee, 2 Year Suspension, 1 Year SR-22



Driving Privileges:

May be granted through a Municipal court. SR-22 must be on file, and reinstatement fee paid or on an active court ordered payment plan.

- 1st offense Privileges are not available
- 2nd offense Privileges are available after a 15-day hard suspension
- 3rd + offense Privileges are available after 30-day hard suspension

Non-Compliance Suspension (NC)

In this example, the Non-Compliance suspension is <u>pending</u> and not yet in effect.

- Acceptable proof of insurance includes an Insurance card, declarations page, or verification letter from the Insurance company.



Judgment Suspension (SJ)

The result of an imposed Judgment by the court due to property damage or personal injury that resulted from the use, care, or maintenance of a motor vehicle.

- This suspension is indefinite as long as the other party is taking collection action
- Not eligible for driving privileges

Reinstatement Requirements:

- File an agreement or release from the other party
- File a court order payment agreement or court order release from the court granting the judgment
- File for Bankruptcy (Chapter 7 or 13)
- If the other party has not taken collection action or had the judgment recertified in 10 years, individual may file the BMV 2204 to have the suspension lifted.

Security Suspension (SS)

Created when a party in an accident or their insurance company files a BMV 3303 alleging the driver/owner was uninsured at the time of the accident and had \$400 or more in damages or injuries.

• 2 year suspension unless active insurance is provided, or a payment agreement/release is received.

Reinstatement Requirements:

- Active proof of insurance on the accident date may remove the suspension.
- Pay damages either in full or with a payment agreement.
 - An agreement will clear both the owner and the driver.
 - Only one payment agreement is allowed.
 - If a payment is missed, the 2 year suspension will be reinforced.
- Make a deposit with the BMV for the full amount of damages.
- File for Bankruptcy (Chapter 7 or 13).



Security Suspension (SS)

MUST SUBMIT AND MAINTAIN SR-22 UNTIL 10/04/2027

Court Order Suspension

A court may order a suspension for a traffic violation. The length of the suspension is determined by the court.

The Court may grant driving privileges.

Reinstatement Requirements:

- \$40 reinstatement fee for minor offense
- \$315 reinstatement fee for major offense
- Provide current proof of insurance

Administrative License Suspension (AR/SI)

A driver is stopped by law enforcement for suspicion of driving under the influence of Alcohol or a controlled substance. The driver is placed under an Administrative License Suspension (ALS) for either a positive result (AR) or refusal (SI) to take the test.

Driving privileges can be granted by the Court after the hard suspension.

Reinstatement Requirements:

- Serve Suspension time based on prior offenses:
 - Positive: 90 days to 3 years
 - Refusal: 1 year to 5 years
- Pay \$315 Reinstatement fee
- Provide proof of insurance that covers the end date of the suspension



Administrative License Suspension (AR/SI)

"SI" indicates an Administrative License Suspension - Refusal

Pre-Trial Suspension (PT)

If someone is arrested for operating a vehicle under the influence of alcohol and/or drugs (OVI) and is not placed under an Administrative License Suspension (ALS) or successfully appeals the ALS, a court may place the individual under a Pre-Trial suspension.

- A Pre-Trial suspension stays in effect until the court notifies the Bureau of Motor Vehicles (BMV) of a decision on the OVI case.
- A court may grant driving privileges.

- Court can grant driving privileges
- Takes down the ALS suspension and reinstatement fees

Physical Control (PH)

Convicted and sentenced by a court of being in physical control of a vehicle while intoxicated.

Reinstatement Requirements:

- Serve the Court Suspension
- Provide proof of insurance that covers the end date of suspension
- Pay a \$315 reinstatement fee
- Court can grant driving privileges
- Takes down the ALS suspension and reinstatement fees

Out of State Drug/ Alcohol Suspension (C5)

An Ohio licensed driver or resident is convicted of an Alcohol or Drug related offense in another state.

Ohio Court of Record can grant driving privileges.

Reinstatement Requirements:

- Serve the 6 months suspension
- Pay a \$40 reinstatement fee

If a court document or official driving record from the state where the offense occurred is provided and lists specific suspension dates with a matching case number, the Ohio BMV will match the suspension dates.

The BMV will no longer suspend drivers for Out of state drug offenses unless the driver would be required to serve a suspension if the offense occurred in Ohio.

In-State Drug Suspension (C4)

- An Ohio licensed driver or resident is convicted of certain drug-related offenses, a court may order a suspension from 6 months to indefinitely.
 Previously, courts were able to impose a license suspension for many drug offenses.
- Under new HB 29, Courts will now only be able to impose a license suspension if the offender "used a vehicle to further the commission of the offense".




Remedial
