

## **Emerging Ministry Grant**

In the Shawnee Valley District, we want every local church- no matter its size- to be challenged and equipped to make new disciples of Jesus Christ by taking risks and being involved in life- giving ministry. We want to put your district apportionments to work by supporting emerging ministries that create opportunities to engage people outside the church. We are looking to provide "seed money" for new and creative ministry that transforms lives.

The provisions of this grant are as follows:

- 1) A grant may be given up to \$3000 per church or church-related, non-profit ministry organization for a specific project.

  An application can be submitted at any time during the year and the review committee will respond within 60 days.
- 2) A church or ministry organization may apply for additional grant monies for the same project over the next two years, but an initial grant does not guarantee future funding.
- 3) A church or ministry organization will be expected to contribute at least 20% of the total cost of the project
- 4) Grants are to be used to expand the church or ministry organization's outreach into the community. This includes (but is not limited to) ministry that reaches out in order to build relationships with new people, expands the caring witness of Christ to the community members who are un-churched and creates new places for new people to come to explore their spiritual need for God.
